# \*\*\*BOARD HIGHLIGHTS - January 2024\*\*\*

- Vice President Donna Habing announced the opening of the Nominating Committee over which the Vice President presides. Donna will provide a list of open positions for 2024-25 in February.
   Updated job descriptions will be on the website for any members that would like to volunteer or submit a nomination for any of the open positions.
- Treasurer Linda Werring reported that the November 11 Magnolia Holiday Arts & Crafts Fair profited \$6,354.64 for our various charities and the Luminaria Fundraiser for scholarships profited \$9,881.65.
- Activities Director Cindy Triay proposed Thursday, February 22, as a date for a social outing to the Fleming Island Spotlight Center Dinner Theater's production of *Breaking Up is Hard to Do*, featuring the songs of Neil Sedaka. At least 27 members and guests must sign up to get the discount price of \$54 per person. For the January10 general meeting, Cindy has lined up Chris Gay to speak to us about growing orchids in Northeast Florida.
- Charles E. Bennett Elementary School (CEB) liaisons Pam Young and Linda Thill completed the first round of shopping for, packing, and delivering grocery items for the 20 families in CEB's Project REACH monthly food pickup program. Feedback from the families involved was very positive. Dates have been set for the remaining monthly deliveries through May 2024, all on Tuesdays at 11:30 a.m.: January 16, February 20, March 19, April 16 and May 21. An eblast will be sent out to members asking for volunteers to help pack the groceries in the coming months. A sign-up sheet will be available at the January general meeting. The membership will vote on a name for the REACH monthly food pickup program from the list of suggested names MPWC members submitted last month.
- Fundraising Director Joanne LaBeouf asked, and the Board agreed, to increase the price of next year's Luminaria kits from \$7.50 to \$8 citing rising costs of Luminaria supplies and brochures.
- Grants Director Nancy Nettuno announced that the Reinhold Foundation has accepted MPWC's four applicants for its leadership classes. Congratulations Marsha Fields, Donna Habing, Linda Werring, and Pam Young.
- MPWC will purchase a \$100 ad for the 25<sup>th</sup> Annual Green Cove Springs Rotary Wrestling Tournament.

# \*\*\*BOARD HIGHLIGHTS - February 2024\*\*\*

- Vice President Donna Habing continues to seek nominations to fill the open Officer and Director positions in MPWC. So far, she has received one nomination for vice president.
- Clay County Schools Director Suzanne Foster reported for Treasurer Linda Werring that funds may
  need to be transferred from MPWC's general unrestricted account into the Feeding Clay County's
  Needy (FCCN) account to sustain Maggie's Beekeepers through the end of this school year. This
  topic will be discussed further at the March Board Meeting.
- Activities Director Cindy Triay reported that 60 members/guests have made reservations for February 23 to attend the Fleming Island Spotlight Center Dinner Theater's production of *Breaking Up is Hard to Do*, featuring the songs of Neil Sedaka. Cindy announced that the program speaker for the February 13 general meeting will be Rod Snow, a local beekeeper and honey producer. For the March meeting, Cindy has procured Vishi Garig from the Clay County Historical Archives in Green Cove Springs to speak to us about old Green Cove Springs and Chef Meeks for April.
- Suzanne Foster reported on the progress of Maggie's Beekeepers, the new name MPWC members voted on for the CEB Project REACH food pick-up program. In January, only 10 of the 20 boxes of groceries were picked up. The remaining 10 boxes were used to restock the CEB Pantry. For this reason, only 10 family boxes of groceries will be packed and delivered on February 22. These numbers may fluctuate from month to month. Enough volunteers have signed up to finish out the current school year.
- The Directory Ads campaign is continuing for 2024 with a few modifications. Cheryl Kennedy has joined the Directory Ads team to assist advertisers with new ads or changes to ads. Cheryl is replacing Joanie Braatz who, after 19 years, has stepped down from her position as ad designer.
- Scholarship Director Marsha Fields reported that 17 requests for scholarship applications have been made so far and she expects more before the cutoff date of March 15.
- The formation of a Community Outreach subcommittee under Activities may be a possibility if one of our members volunteers to be the Chair. This subcommittee would organize non-monetary charitable activities such as bellringing for the Salvation Army at Christmas, collecting food items for the Green Cove Springs Food Pantry, cookies for Tad's Toys, blankets for the local homeless shelter, etc.

# \*\*\*BOARD HIGHLIGHTS - March 2024\*\*\*

- Phyllis Skarbrevik needs paper bags for Waste Not Want Not and Pam Young needs a few for Maggie's Beekeepers. Paper bags can be deposited in the bin at the front guard gate or brought to General Meetings.
- The Board voted to reduce the \$10,000 reserve in the restricted Scholarship Account to \$5,000 so that Scholarship Director Marsha Fields may access more funds for Scholarships if needed.
- Pam Young reported that it is not certain if Maggie's Beekeepers will continue next school year. She feels CEB's needy families may be better served with the Pantry.
- Activities Director Cindy Triay, Lorna Broughton, Jackie Maneval, and Pam Brame met with Deneen Rothfels at the Country Club to plan the menu for the May 8 Installation Luncheon. The cost per person is \$25 for an entrée, drink, dessert, and gratuity. The Board voted to cover \$10 per person of the \$25 fee.
- Cindy Triay announced that our own Chef Meeks at MPGCC will be the speaker for the April 10 program. Cindy is looking into another social outing at the Fleming Island Spotlight Dinner Theater featuring the music of Patsy Cline. The March 13 program speaker is Robert Sullivan, a District Chief with Alachua County Fire Rescue in Gainesville. Robert plans to address the following topics: what happens when you call 9-1-1; heart attacks and strokes; cardiopulmonary resuscitation and the use of the automated external defibrillator (AED); choking and airway obstruction; fall prevention; fire safety for the elderly.
- Vice President Donna Habing, as Chair of the Nominating Committee, announced that all Officer, Director and Chair positions have been filled except for the Social Chair and Bannerman Liaison. Anybody interested? She extends her gratitude to all those who volunteered to fill the open positions and hopes more members will become involved in our committees. Donna's mantra as next term's President is "More for Members" and she is hoping to have six Socials and six Community Outreach projects.
- Treasurer Linda Werring reported that \$2,500 is available for Charitable Giving and must be dispersed before the end of fiscal year. The Board is looking into several possible recipients based on the Charitable Giving Survey conducted in September.

# \*\*\*BOARD HIGHLIGHTS - April 2024\*\*\*

- Vice President Donna Habing, as Chair of the Nominating Committee, announced that all Executive Officer, Director, and Chair positions have been filled! The vote for the 2024-2025 Slate of Executive Officers will take place at the April 10 general meeting. The Slate is as follows: President -Donna Habing, Vice President Pam Young, Corresponding Secretary Adele Murphy, Recording Secretary Bobbe Marion, Treasurer Linda Werring, and Immediate Past President/Advisor Lorna Broughton. Before the vote, nominations will be requested from the floor. It is very important that a quorum be present for this vote.
- The annual MPWC membership dues for 2024-25 will be collected from May 1 through May 31. Dues are \$35. Members may pay \$35 by check or cash directly to Treasurer Linda Werring or pay online by credit card. Members paying their dues online by credit card will incur a processing fee of \$1.50, bringing the total payment to \$36.50.
- Treasurer Linda Werring reported that MPWC has \$3,000 available to support worthwhile causes that align with our mission statement. This money must be donated before the end of the fiscal year, which is April 30. After review and discussion, and based on the Charities Survey done September 2023, the Board voted to donate \$1,000 each to Operation Barnabas, Hope Therapy, and Friends of the Augusta Savage Arts & Community Center. The \$1,000 donation to each of these three charities requires a vote of approval by the members at the April 10 general meeting. The vote will be by secret ballot. President Lorna Broughton sent an email blast to all members providing information about each charity and emphasized the importance of a quorum at the meeting.
- Activities Director Cindy Triay has finalized the menu for the May 8 Installation Luncheon. The cost per person is \$25 for an entrée, drink, dessert, and gratuity. MPWC will cover \$10 per person of the \$25 fee. The RSVP and menu choices will be emailed very soon. Cindy and Sandy Waldrup are planning a fun activity at the luncheon and are asking members to provide them with a high school photo, either hard copy or digital.
- Cindy Triay announced that our own Chef Meeks at MPGCC will be the speaker for the April 10 program. He plans to show us variations we can use with risotto and a new dessert that will be on MPGCC Spring menu.
- Cindy Triay is proposing a social outing in June at the Fleming Island Spotlight Dinner Theater featuring the music of Patsy Cline. She will survey members at the April 10 general meeting to see how much interest there is. The cost is \$31 per person for the show and a box lunch.
- Joanne LaBeouf reported that the Arts & Crafts Fair team is on target with their timeline. Issues and concerns from the 2023 Fair have been reviewed and remedied. Sandy Waldrup confirmed the online vendor application will be ready in May. Nancy Catudal has filled all but four of the coordinator positions and will spearhead Phase II in June.
- Donna Habing, Pam Young, Linda Werring, and Marsha Fields enjoyed participating in the March 7 Reinhold Foundation's "Nonprofit Leadership Development Seminar, Best Practices for High Performing Boards". They were able to interact with several representatives from various Clay County not-for-profit organizations and came away with many noteworthy points.

# \*\*\*BOARD HIGHLIGHTS - May 2024\*\*\*

- As of May 4, 60 members have signed up for the May 8 Officer Installation and Member Luncheon.
   Sandy Waldrup and Cindy Triay have the photo booklet and the Power Point slideshow completed for the "Who Is She" activity for the meeting.
- For Teacher Appreciation Week, May 6-May 10, Pam Young and Linda Thill have purchased twenty \$5 gift cards from local restaurants to be used as prizes for the activities planned for the teachers at Charles E. Bennett Elementary School.
- Hospitality Chair Diane Lochner advised that she has changed to a more cost-effective bag which is beige canvas. She also reported the MPGCC is adding a "Buy 1 Drink, Get 1 Free" to their information folder which is included in the Hospitality bags.
- Marsha Fields reports that the Scholarship Committee has selected four winners for the MPWC scholarships. The Committee is awarding \$5,000, \$4,000 and two \$3,000 scholarships for a total of \$15,000. The Committee had a pool of very qualified young ladies. There will be two openings on the Scholarship Committee for the 2024-25 year which is a three-year commitment. Marsha will announce the openings at the general meeting, and anyone interested needs to contact her. Marsha would like the new Scholarship Committee members to be those who are involved with MPWC and come to the general meetings.
- Lorna Broughton suggested that a clarification of proxy voting at general meetings is needed in the MPWC Bylaws. Because proxy voting is important to its members, Sandy Waldrup offered to make changes to the language of Sections 2.3, 3.6, and 3.7 of the Bylaws to better define the use of proxy voting at general meetings. The Board will vote on these clarifications at the June 5 Board meeting.
- To facilitate the correct usage of Robert's Rules of Order, the Board voted that the Vice President be appointed official Parliamentarian to preside at all MPWC meetings.
- For the purpose of helping Board members recall and easily locate Board policies when necessary, the Board agreed that the Corresponding Secretary be the repository of a master list of Board policies and that these policies also be sent to the Communications Director and uploaded to the Governance section on our Website.
- Because of ongoing questions regarding membership dues, Sandy Waldrup offered to write a policy addressing the definition of "new member," fees paid by a previous member rejoining after a lapsed membership, fees paid by new members who join after January 1, and the Treasurer's option to make fee decisions when someone is joining before May 1. At the June 5 meeting, the Board will further discuss and vote on these issues. Treasurer Linda Werring specified that only new members who join MPWC after January 1 will be allowed to pay the reduced dues of \$15.00.
- The Board clarified that any MPWC member in a leadership position, or identified as a potential leader, are eligible to attend the Reinhold Foundation's seminars. MPWC's Reinhold Foundation liaison, who will be responsible for providing information regarding leadership seminars, is the Immediate Past President.
- Sandy Waldrup asked consideration in the future that our charitable donations not be given to other not-for-profit organizations.

# \*\*\*BOARD HIGHLIGHTS - August 2024\*\*\*

- John Poluga, JP's Custom Carts, will be holding a raffle for a refurbished golf cart to advertise his business. He would like to donate the profits to a not-for-profit and is considering the Women's Club as well as other not-for-profits. President Donna Habing will keep the Board posted as to his decision.
- Sandy Waldrup announced that the membership directories have been printed and she will pick them up on Monday and deliver them to Diane Lochner for distribution to the members.
- Marsha Fields, MPWC's accountant, explained the difference between a not-for-profit under IRS laws and a non-profit under Florida State law. The Women's Club was approved as an IRS charitable organization years ago. Marsha clarified that contrary to rumor, the Women's Club can give donations to other 501(c)(3) organizations. The only restrictions MPWC has is that it cannot give to any political organizations or a 501(c)(4) corporation (lobbying). Donna will bring this up at the next general meeting.
- Adele Murphy distributed a draft Code of Conduct for MPWC that she and Bobbe Marion researched and developed. Adele noted that there is no code required by the State of Florida and such codes were more directed to larger agencies with paid officers and board members, like the United Way. Discussion centered around whether such a policy was even needed, or whether a verbal reminder was a better way to handle any potential issues. Several Board members relayed instances they felt could have benefitted from such a policy. After discussion, Donna tabled the topic for further discussion at the September Board meeting.
- Treasurer Linda Werring noted after her presentation at the July meeting about the monies the Club has donated, several members approached her about putting the information in an email. Linda explained that all financial information can be found on the website. Linda also reported that MPWC purchased two season tickets for the Orange Park Community Theater (OPCT) for \$250 to be given away in drawings at the General meetings.

- Donna Habing, Marsha Fields and Nancy Catudal will attend the Reinhold Fall Nonprofit Leadership Breakfast October 15 at the Thrasher-Horne Conference Center.
- The Board unanimously voted to consider MPWC's charitable donations on an ad-hoc basis rather than every quarter. At the end of the fiscal year, when the Treasurer indicates how much money is left for donations, the Board will decide which charity(ies) to donate to, based on the Charities Survey the members completed earlier this year, and how much each charity would receive. This approach will give MPWC flexibility so that during the year any requests for emergency funds can be considered.
- The Board unanimously voted to reallocate Directory Ad profits from the restricted scholarship account to the general charitable fund. With Board approval, the Scholarship Director may access the funds in the general charitable account if needed.
- Treasurer Linda Werring reported that \$128.90 was donated to the Green Cove Springs Junior High School nurse for the purchase of supplies. MPWC purchased fifty \$5 Dunkin' Donuts gift cards for Bannerman Learning Center. The gift cards will be used for the Citizen of the Week Awards.
- Fundraising Director Joanne LaBeouf reports that:

This program provides a second chance to men with ties to Clay County who have been involved with the criminal justice system. Pastor Sanders shared with the Board the history, purpose, current work, and building plans of the VTC. Pastor Sanders invited Magnolia Point Women's Club (MPWC) members to attend their groundbreaking ceremony on November 15, 2024, the beginning of a six-year project. The Board decided to revisit the possibility of a donation to VTC after the completion of the MPWC's November and December fundraisers.
