**EXECUTIVE OFFICER REPORTS**

**President (Pam Young)**

I will be unable to attend the February Board meeting, I ask Vice President Adele Murphy to facilitate the February Board meeting in my absence.

**Finance Report (Linda Werring, Treasurer):**

- \$450 was deposited into the unrestricted money market account for the Holiday Home Tour. This amount will go towards the 25<sup>th</sup> anniversary event.
- Resident donations for the scholarship fund from the luminaria event totaled \$3,616.00. This amount will be transferred from the unrestricted money market account and put into the scholarship account. Luminaria kit sales totaled \$10,976.00. When the treasurer confirms there are no more expenses to be accounted for, the net proceeds will be transferred from the unrestricted money market account into the scholarship account – approximately \$6,000.00.
- A \$5,000 donation was given to the club in December for scholarships.
- A \$50 memorial donation to St. Jude's Research Hospital was made in memory of Penny Murphy's late husband.

Funds for charitable giving:

- \$6,113.48 in the unrestricted money market account remains from previous years' fundraising
- \$6,271.01 in the unrestricted money market account is this year's Designer Bag Bingo profits  
**\$12,384.49 is in the unrestricted money market account from fundraising**
- \$7,500 in the reserves/savings account must be used for FCCN/schools/charities

**COMMITTEE REPORTS**

**Activities (Susan Hanline, Director):**

Events:

- A member outing to visit the Cummer Museum to see the exhibit of Andrew Wyeth is planned for early February.

- A members and family picnic is planned similar to what was done last year.

Programs:

- A local author has been contacted to be a guest speaker for the March meeting. Hope to hear back soon on availability.
- April meeting we will have an activity, more information to follow.

**Communications (Sandy Waldrup, Director):**

- Membership Database: No new members as of January 2026. Sandy updated the “Join” membership tab on the website to reflect the reduced rate from January through April 30.
- Printshop (Sandy Waldrup): No print requests for the month.
- Social Media (Susan Mitchell): Facebook postings are ongoing. Sandy continues to send articles for The Magnolia Living, which includes gathering photos.
- Webmaster (Joanne LaBeouf): Sandy substituted generic luminaria pages and also updated the “Join” membership page to show the reduced rate. Sandy combined the 2024 regular member meetings into one document, and created a new section for 2026 meeting minutes. Routine maintenance and upgrades are ongoing. On December 4, Joanne and Sandy met with Marv Conn, MagicAngel, whose business has taken over our website hosting/servicing, and the meeting was very informative. Marv also provided detailed information regarding the migration to his servers, and indicated the migration occurred much sooner than was anticipated because the old “owner’s” health deteriorated very fast and Marv had to absorb a lot of the migration costs himself since not all the “steps” were in place.

**Clay Schools (Judy Sessions, Director):**

- In January Director Sessions will reach out to the Clay County High school for any new requests.

**Fundraising (Nancy Catudal, Director):**

- Fundraisers: At November and December's meeting. ideas were proposed for future Fundraising events this board year. Also, the idea of no other Fundraising events excluding the spring yard and plant sale was proposed. The spring yard and plant sale has a chair: Donna Habing. It is to be held on Saturday, April 25, 2026 at the Exit Realty parking lot. Plans are underway to maximize this Fundraising event.
- Luminaria (Nancy Mills, Chairperson): The Luminaria night on December 13th was a success, although less Luminary kits were sold this year. See Linda Werring's treasurer report for financial posting.
